IF YOU HAVE APPLIED VIA PAPER YOUR CHOSEN SCHOOL WILL WRITE TO YOU.

SHOULD YOU HAVE APPLIED FOR A PLACE WITHIN ONE OF THE FEDERATION SCHOOLS, YOU SHALL ALSO RECEIVE A LETTER DETAILING TASTER SESSIONS AND ADDITIONAL INFORMATION O2<sup>ND</sup> MAY (ACTUAL DATE TBC BY ESCC) - CLOSING DATE FOR ANY PARENTS WISHING TO LODGE AN APPEAL WITH THE SCHOOL WHICH THEY REQUESTED BUT WERE NOT ALLOCATED.

A CONFIRMATION LETTER

WITHIN).

CONFIRMATION LETTER SENT TO PARENTS APPEALING FROM RELEVANT FEDERATION SCHOOL REQUESTING RSVP FOR ATTENDANCE TO THE HEARING OF THE APPEAL (VENUE AND ACTUAL DATE TBC DEPENDENT UPON NUMBER OF APPEALANTS). THERE WILL ALSO BE THE OPPORTUNITY TO FORWARD ADDITIONAL EVIDENCE FOR THE APPEAL PANELS PERUSAL E.G DOCTORS LETTERS ETC.

THE APPEAL PANEL WILL BE MADE UP OF X3
INDEPENDENT MEMBERS. THE FEDERATION WILL BE
REPRESENTED BY A MEMBER OF THE SLT TEAM AND A
MEMBER OF THE GOVERNING BODY. A CLERK FOR THE
APPEAL HEARING WILL ALSO BE PRESENT.

THE APPEAL DECISION WILL BE CONVEYED IN WRITING TO PARENTS WITHIN 5 WORKING DAYS OF THE APPEAL.
